ORDER OF DISMISSAL

This case comes to the Board on appeal from the July 8, 2013 decision from the Division of Traffic Engineering denying the requested reserved handicapped parking space at 1122 Foxwood Lane.

On August 12, 2013, Nicholas Silwonuk, Sr. filed a Notice of Appeal from the decision of the Division of Traffic Engineering. A hearing was scheduled to be held before this Board on Wednesday, October 16, 2013 at 10:00 a.m., for which proper notice was given. Edward Reed, Jr. and Mark Gonce, from the Department of Public Works, appeared on behalf of Baltimore County at the scheduled time of hearing; Nicholas Silwonuk, Sr., Applicant/Appellant, did not appear, nor did anyone appear on his behalf.

The Board convened at 10:38 a.m., and, on the record and in open hearing, Edward Reed, Jr. and Mark Gonce, from the Department of Public Works for Baltimore County moved for dismissal for failure to appear. Upon consideration of the fact that the Notice had the correct address and was not returned, the Board granted said Motion for Dismissal and will so order.




