WHEREAS, the Board convened for a hearing on February 24, 2015. Michael McGinn, appeared pro se. Jonny Akchin, Assistant County Attorney, appeared on behalf of Baltimore County, Maryland.


WHEREAS, the Board finds that citations E45375A, E45375B were issued on September 11, 2014 and were heard by the Animal Hearing Board on September 16, 2014. Consequently, this Board finds that the Respondent was not afforded sufficient time or notice to prepare for the September 16, 2014 hearing, pursuant to Baltimore County Code Section 12-8-102(e)(1) and that these citations shall be remanded to the Animal Hearing Board to be heard de novo.

WHEREAS, the Respondent is hereby instructed that he has 5 days from the date of this order to file a request for hearing before the Animal Hearing Board, pursuant to Baltimore County Code Section 12-8-102(e)(1).

IT IS THEREFORE, this 24<sup>th</sup> day of February, 2015, by the Board of Appeals of Baltimore County,


**ORDERED** that the above captioned case number CBA-15-007 is hereby REMANDED to the Animal Hearing Board for Baltimore County for further proceedings.


