INTRODUCTION

The information included in this resource guide is taken directly from the 2003 edition of the “Out and About Travel Guide,” which is published by the Baltimore Metropolitan Council in response to a request by the Baltimore Regional Transportation Board, as a public service to residents of the Greater Baltimore Region who have specialized travel needs.

The purpose of the “Out and About Travel Guide” is to provide easy-to-use information for individuals with special mobility needs, their caregivers, and other interested individuals. The guide lists public transportation and specialized transportation services available in the greater Baltimore area.

The “Out and About Travel Guide” will assist individuals who are elderly or disabled to locate and use transportation services that are adapted to meet their specialized transportation needs on a regular or occasional basis.

The Baltimore County Commission on Disabilities has long been concerned about the difficulty facing people with disabilities in regards to transportation services. It has, in the past, published its own transportation pamphlet. However, it recognizes the in-depth study that the Transportation Planning Division of the Baltimore Metropolitan Council has done on this issue, and, with permission from the Council, has published this abridged version of the “Out and About Travel Guide” which addresses only those transportation services directed towards those individuals with disabilities in the immediate Baltimore County area who are not receiving transportation services as part of a day or vocational program sponsored by a community service organization.

The Baltimore County Commission on Disabilities extends its sincere thanks to the Baltimore Metropolitan Council for permission to reprint portions of its Guide.
