A BILL
ENTITLED

AN ACT concerning

The 2008-2009 Current Expense Budget
Gifts and Grants Special Revenue Fund
Special Supplemental Nutrition Program
For Women, Infants & Children (WIC)

FOR the purpose of amending the 2008-2009 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds and made available to the County through the State of Maryland Department of Health and Mental Hygiene.

WHEREAS, the Maryland Department of Health and Mental Hygiene has made an award of federal funds available to the Baltimore County Department of Health, to be used for the purpose of maintaining client access to services and benefits, and expanding the interaction of WIC with other maternal and child services; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections
3 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore
4 County Code, 2003, as amended, that the Current Expense Budget for the fiscal year ending
5 June 30, 2009, be and is hereby amended by appropriating federal funds made available to
6 the Baltimore County Department of Health, in the amount herein specified, to the following
7 program:

8 005-030-0929 Special Supplemental Nutrition Program for WIC \$19,600

9 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed
10 by the affirmative vote of five members of the County Council, shall take effect on February
11 15, 2009.
