A BILL
ENTITLED

AN ACT concerning

The 2007-2008 Current Expense Budget
Gifts and Grants Special Revenue Fund
Monitoring/Technology Enhancements - Sex Offender Compliance and
Enforcement in Maryland (SOCEM) Program

FOR the purpose of amending the 2007-2008 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from state funds and made available to the County through the Governor's Office of Crime Control and Prevention.

WHEREAS, the Governor's Office of Crime Control and Prevention has made an award of state funds available to the Baltimore County Police Department to be used to continue the monitoring and registration of sex offenders and to maintain a constant knowledge of their whereabouts in Baltimore County; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants

Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF
2 BALTIMORE COUNTY, MARYLAND, pursuant to the power and authority conferred
3 upon it by Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-
4 102 of the Baltimore County Code, 2003, as amended, that the Current Expense Budget
5 for the fiscal year ending June 30, 2008, be and is hereby amended by appropriating state
6 funds made available to the Baltimore County Police Department, in the amount herein
7 specified, to the following program:

8 005-015-1574 Monitoring/Technology Enhancements - SOCEM Program

10 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been
11 passed by the affirmative vote of five members of the County Council, shall take effect
12 March 3, 2008.
