A BILL
ENTITLED

AN ACT concerning

The 2007-2008 Current Expense Budget
Gifts and Grants Special Revenue Fund
Workforce Investment Act Program

FOR the purpose of amending the 2007-2008 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds and made available to the County through the Maryland Department of Labor, Licensing and Regulation.

WHEREAS, the Maryland Department of Labor, Licensing, and Resolution has made an award of Federal funds available to the Baltimore County Department Office of Workforce Development to be used for employment and training activities; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special

Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections
3 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore
4 County Code, 2003, as amended, that the Current Expense Budget for the fiscal year ending
5 June 30, 2008, be and is hereby amended by appropriating federal funds made available
6 through grants from the Maryland Department of Labor, Licensing and Regulation to the
7 Baltimore County Office of Workforce Development, in the amount herein specified, to the
8 following program:

9 005-087-8731 Workforce Investment Act (WIA) Adult Programs \$15,375

10 005-087-8734 Workforce Investment Act (WIA) Adult Programs \$94,218

11 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed
12 by the affirmative vote of five members of the County Council, shall take effect June 15,
13 2008.
