FOR the purpose of amending the 2011 – 2012 Capital Budget, by appropriating to the ~~Gifts and Grants Special Revenue Fund~~ Capital Budget monies derived from grant funds and made available to the County through the State ~~or~~ of Maryland.

WHEREAS, in accordance with Section 716 of the Baltimore County Charter, the County Council may, upon recommendation of the County Executive, amend the Capital Budget; and

WHEREAS, the State of Maryland has made an award of funds available to the Baltimore County Department of Environmental Protection and Sustainability, to be used for stream restoration and conversion of stormwater management ponds to stormwater quality devices; ~~and~~

~~WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and~~

~~WHEREAS, such fund remains open perpetually as a mechanism to account for the grant~~

appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by ~~Sections 306~~
3 ~~and 712(a)~~ Section 716 of the Baltimore County Charter ~~and Section 10-6-102 of the Baltimore~~
4 ~~County Code, 2003, as amended,~~ that the ~~Current Expense~~ Capital Budget for the fiscal year ending
5 June 30, 2012, be and is hereby amended by appropriating State funds made available to the
6 Baltimore County Department of Environmental Protection and Sustainability, in the amount herein
7 specified, to the following program:

10 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by the
11 affirmative vote of five members of the County Council, shall take effect October 16, 2011.
