A BILL  
ENTITLED

AN ACT concerning

The 2007-2008 Current Expense Budget  
Gifts and Grants Special Revenue Fund  
Substance Abuse Adolescent Treatment - Functional Therapy Project

FOR the purpose of amending the 2007-2008 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from state funds and made available to the County through the Governor's Office for Children to the Baltimore County Local Management Board.

WHEREAS, the Governor's Office for Children, has made an award of state funds available to the Baltimore County Local Management Board for the Department of Health, Bureau of Substance Abuse, to be used for their implementation and support of Functional Family Therapy for adolescents and their families; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants

Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, that the Current Expense Budget for the fiscal year ending June 30, 2008, be and is hereby amended by appropriating federal funds made available through a grant from the Governor's Office for Children through the Baltimore County Local Management Board to the Baltimore County Department of Health Bureau of Substance Abuse, in the amount herein specified, to the following program:
