A BILL  
ENTITLED

AN ACT concerning

Final Historical Landmarks List

FOR the purpose of adding new landmarks to the Final Historical Landmarks List; and generally relating to the Baltimore County Historical Landmarks List.

WHEREAS, the Landmarks Preservation Commission has met and compiled a preliminary list of additional structures to be added to the Final Historical Landmarks List; and

WHEREAS, the following structures have been identified on the preliminary landmarks list by the Commission and have been review by the County Executive; and

WHEREAS, a public hearing was held by the County Council on July 7, 2008 to determine which structures should be included on the “final landmarks list”; and

WHEREAS, the County Council finds that the following structures contribute substantially to the architectural and historical heritage of the county, state, or nation; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
2 COUNTY, MARYLAND that new items 352 through 363 inclusive, be and they are hereby

21 SECTION 2. AND BE IT FURTHER ENACTED, that this Final Historical Landmarks List  
22 shall be maintained by the Landmarks Preservation Commission as provided in Section 32-7-106  
23 of the Baltimore County Code, 2003, as amended.

24 SECTION 3. AND BE IT FURTHER ENACTED, that this Act, having been passed by the  
25 affirmative vote of five members of the County Council, shall take effect on September 15, 2008.
