A BILL  
ENTITLED

AN ACT concerning

The 2007-2008 Current Expense Budget  
Gifts and Grants Special Revenue Fund  
Forensic DNA Backlog Reduction Program

FOR the purpose of amending the 2007-2008 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds and made available to the County through the U.S. Department of Justice/Office of Justice Programs.

WHEREAS, the U.S. Department of Justice/Office of Justice Programs has made an award of federal funds available to the Baltimore County Police Department to be used to purchase DNA forensic laboratory equipment to assist in the reduction of backlogged DNA cases.

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1           SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306  
3 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code,  
4 2003, as amended, that the Current Expense Budget for the fiscal year ending June 30, 2008, be and  
5 is hereby amended by appropriating federal funds made available to the Baltimore County Police  
6 Department in the amount herein specified, to the following program:

7           005-015-1593           Forensic DNA Backlog Reduction Program \$244,837.00

8           SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by the  
9 affirmative vote of five members of the County Council, shall take effect January 20, 2008.
