A BILL  
ENTITLED

AN ACT concerning

The 2008-2009 Current Expense Budget  
Gifts and Grants Special Revenue Fund  
Waterway Improvement Fund Grant

FOR the purpose of amending the 2008-2009 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from State funds and made available to the County through the Maryland Department of Natural Resources (DNR).

WHEREAS, DNR has made an award of funds available to the Baltimore County Office of Homeland Security and Emergency Management, to be used for enhanced rescue capabilities; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2003, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1           SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306  
3 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code,  
4 2003, as amended, that the Current Expense Budget for the fiscal year ending June 30, 2009, be and  
5 is hereby amended by appropriating funds made available through a grant from the Maryland  
6 Department of Natural Resources to Baltimore County in the amount herein specified to the  
7 following program:
