A BILL  
ENTITLED

AN ORDINANCE concerning Agricultural and Rural Land Preservation  
Borrowing

FOR the purpose of authorizing and empowering Baltimore County, Maryland to borrow money in a principal amount not exceeding \$1,000,000 for land preservation to be undertaken in the ensuing fiscal years starting July 1, 2013, and to provide that the full amount of such borrowing shall be submitted to a referendum of the registered voters of Baltimore County for their approval or rejection, pursuant to Section 718 and Section 705(a) of the Baltimore County Charter.

WHEREAS, in accordance with the provisions of Section 705(a) of the Baltimore County Charter, at the direction of the County Administrative Officer, the Director of Planning has heretofore transmitted to the Director of Budget and Finance the

recommendations of the Planning Board for borrowing for capital projects to be undertaken in the ensuing fiscal years starting July 1, 2013 and of a character requiring authorization by referendum; and

WHEREAS, the County Administrative Officer has reviewed such recommendations with the Director of Budget and Finance in the light of the existing capital program and has submitted to the County Executive a Borrowing Plan for the forthcoming referendum; and

WHEREAS, the County Executive, after approving or modifying said Borrowing Plan, has submitted said Borrowing Plan to the County Council for approval; and

WHEREAS, as a part of said Borrowing Plan it has been recommended that Baltimore County, Maryland, borrow a sum not exceeding \$1,000,000 for the purpose of purchasing land, development rights, conservation easements and other real property approved by the Baltimore County Council pursuant to the Maryland Agricultural Land Preservation Program and the Rural Legacy program or other similar federal or state programs to be undertaken in the ensuing fiscal years starting July 1, 2013; now therefore

1           SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
2           COUNTY, MARYLAND, that Baltimore County, Maryland, is authorized to borrow a sum  
3           not exceeding \$1,000,000 for the purpose of purchasing land, development rights,  
4           conservation easements and other real property approved by the Baltimore County Council  
5           pursuant to the Maryland Agricultural Land Preservation Program and the Rural Legacy  
6           Program or other similar federal or state programs to be undertaken in the ensuing fiscal  
7           years starting July 1, 2013.

1           SECTION 2. AND BE IT FURTHER ENACTED, that for the purpose of  
2 implementing the Borrowing Plan referred to in Section 1 of this Ordinance, Baltimore  
3 County, Maryland is hereby authorized, upon its full faith and credit, to borrow money and  
4 to incur indebtedness for financing the purchase of land, development rights, conservation  
5 easements and other real property approved by the Baltimore County Council pursuant to  
6 the Maryland Agricultural Land Preservation Program and the Rural Legacy Program or  
7 other similar federal or state programs. In evidence of such borrowing and indebtedness,  
8 Baltimore County, Maryland, is hereby authorized and empowered to issue its general  
9 obligation bonds, at one time or from time to time, in various series, and in a principal  
10 amount not exceeding the amount authorized to be borrowed under said Section 1 of this  
11 Ordinance. Any general obligation bonds to be issued pursuant to the authority conferred  
12 by this Ordinance and the forthcoming referendum shall be issued and sold pursuant to Bond  
13 Issuance Authorization Ordinances adopted in accordance with Section 709 of the Baltimore  
14 County Charter, as set forth in the Baltimore County Code, 2003, as amended, and other  
15 applicable provisions of law.

16           SECTION 3. AND BE IT FURTHER ENACTED, that this Ordinance may be cited  
17 as “Baltimore County 2012 Agricultural and Rural Legacy Land Preservation Borrowing  
18 Plan Ordinance”.

19           SECTION 4. AND BE IT FURTHER ENACTED, that pursuant to Section 718 and  
20 Section 705(a) of the Baltimore County Charter and Section 10-3-103 of the Baltimore  
21 County Code, 2003, as amended, the County Executive shall cause to be placed on the ballot  
22 by the Board of Supervisor of Elections of Baltimore County for referendum in the general

1 election to be held in Baltimore County on November 6, 2012, the full amount of the  
2 borrowing authorized by this Ordinance.
