LEGISLATIVE SESSION 2016, LEGISLATIVE DAY NO. 14
August 30, 2016 6:00 P.M.

B. CALL OF BILLS FOR FINAL READING AND VOTE

Bill 54-16- The Comprehensive Zoning Map - First District, was called. Councilman Quirk moved to accept the Planning Board's recommendation on the following issues:
