A RESOLUTION to rank five Rural Legacy Area Plan applications submitted to the Maryland Department of Natural Resources for consideration and approval by the Maryland Rural Legacy Board for funding in fiscal year 2011. These plans include the Baltimore County Coastal, Gunpowder River, Long Green Valley Area, Manor Area and Piney Run Area.

WHEREAS, the Maryland Rural Legacy Program was adopted as part of the “Smart Growth” initiative submitted by the Governor and approved by the Maryland General Assembly during the 1997 session of the Maryland General Assembly to be administered by the Maryland Department of Natural Resources in accordance with Sections 5-9A-01 through 5-9A-09 inclusive, Natural Resources Article, Annotated Code of Maryland; and

WHEREAS, the Maryland General Assembly declared that “sprawl development and other modifications to the landscape in Maryland continue at an alarming rate, consuming land rich in natural resource, agricultural, and forestry value, adversely affecting water quality, wetlands, and habitat, threatening resource-based economies and cultural assets, and rending the fabric of rural life;” and

WHEREAS, “current State, county, and local land conservation programs help to limit the effect of sprawl development but lack sufficient funding and focus to preserve key areas before escalating land values make their protection impossible or the land is lost to development;” and

WHEREAS, “a grant program that leverages available funding, focuses on preservation of

strategic resources, including those resources threatened by sprawl development, streamlines real property acquisition procedures to expedite land preservation,... and promotes a greater level of natural and environmental resources protection than is provided by existing efforts, will establish a rural legacy for future generations;” and

WHEREAS, Baltimore County is particularly rich in natural resources, is recognized statewide and nationally for its resource protection zoning and regulations, is a leader nationally in agricultural and environmental lands protected through privately held easements, and receives the benefit of having several well established and successful Local Land Trusts and Community Organizations; and

WHEREAS, the five plans listed below have been reviewed and endorsed by the County Executive as consistent with the County’s master planning, zoning, capital improvement program, natural resource protection, and other policies and programs of Baltimore County:

1. Piney Run Watershed Rural Legacy Area; and
2. (tie) Manor Rural Legacy Area; and
2. (tie) Gunpowder River rural Legacy Area; and
3. Baltimore County Coastal Rural Legacy Area; and
4. Long Green Valley Rural Legacy Area; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF BALTIMORE COUNTY, MARYLAND, that Baltimore County approves and endorses the five applications listed above in the priority listed for Rural Legacy Area designation; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect from the date of its enactment.
