A RESOLUTION to expand Residential Permit Parking area, in accordance with the procedures of Section 18-4-402, of the Baltimore County Code, 2003, for the area of Southland Hills in West Towson outlined on the attached plat.

WHEREAS, the Division of Traffic Engineering has been contacted by four households of Alabama Rd (#314-320, (even) who desire to again be included within the boundaries of Residential Permit Parking Area “B,” and

WHEREAS, these same four households were added to Area “B” by action of the County Council in 1982 under Resolution 87-82 after having met the criteria established in what is now Section 18-2-403 of the Baltimore County Code, and

WHEREAS, these same four households were removed from Area “B” by action of the County Council in 2009 under Resolution 33-09 after said households requested to be removed under the provisions of Section 18-2-405 of the Baltimore County Code, and


WHEREAS, the Director of Public Works has acknowledged that these same four households have now re-evaluated the parking situation on Alabama Rd and desire to again be re-established within the boundary of Residential Permit Parking Area “B” as they had been for 27 years (from 1982 to 2009), and that the Director of Public Works therefore recommends that

the area indicated on the attached plat be designated as part of existing Residential Permit Parking Area “B”.

BE IT RESOLVED BY THE COUNTY COUNCIL OF BALTIMORE COUNTY, that the area outlined on the attached plat as “Proposed Addition to Permit Area “B” (#314 through #320 (even) Alabama Road) be and is hereby designated and established as being incorporated into and part of existing Residential Permit Parking Area “B,” and

BE IT FURTHER RESOLVED, that the Chairman of the County Council of Baltimore County, Maryland shall endorse the attached plat to indicated that it is the official plat of “Residential Permit Parking Area B,” and the Secretary to the County Council shall thereafter deliver said plat along with a copy of this Resolution to the Director of Public Works for custody with a copy of the plat to be delivered to the Department of Permits, Approvals & Inspections; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect upon the date of its passage by the County Council.
