# Steelworkers Health and Welfare Fund

- Eligible Participants
  - Hourly Actives
  - Hourly Pre-Medicare Retirees
  - Hourly Medicare Retirees
  - Salaried Actives

## Steelworkers Health and Welfare Fund

- Covered Benefits
  - Medical (PPO)
  - Dental
  - Vision
- Prescription Drug coverage was sponsored by RG Steel – not eligible for COBRA

## Steelworkers Health and Welfare Fund

- COBRA
  - Normal duration for actives (18-29 months)
  - Lifetime for retirees (PM and Medicare)
  - Qualified HCTC plan
  - Retirees already in COBRA status for Dental/Vision can run out current duration period.

  - Direct Pay plan
  - 2012 Monthly Premiums
    - \$225/adult with Rx
    - \$119/adult without Rx

- Rx Benefit
  - \$10 per adult monthly premium
  - Available to Pre-Medicare and Medicare retirees and their eligible dependents
  - CVS/Caremark is pharmacy benefit manager
  - RETAIL COPAYS
    - \$5 Generic/\$20 Brand formulary/\$35 Brand non-formulary
  - MAIL ORDER COPAYS
    - \$10 Generic/\$40 Brand formulary/\$70 Brand non-formulary
  - \$9,000 Annual Max for Brand. Unlimited Generic
