Master General License

Authorizes the holder thereof to install, repair, or erect any kind of electrical wiring, conduits, machinery, appliances, motors, fixtures, signs, electrically operated heating equipment, elevators, or any other electrical apparatus or device in or about any premises in Baltimore County.

Limited License

(Limits license holder to represent and perform work in one industrial type building in Baltimore County)
Authorizes the holder thereof to install, repair, maintain or erect any kind of electrical wiring, conduits, machinery, appliances, motors, fixtures, signs, electrically operated heating equipment, elevators, or any other electrical apparatus or device, but only on the premises of his employer in Baltimore County (no work for the public)

Restricted License

Authorizes the holder thereof to install, maintain, and repair low voltage equipment and wiring operating at 50 volts or less.
