## REGISTRATION APPLICATION FOR MINIBIKES AND OFF-THE-ROAD MOTORCYCLES:

Includes motor vehicles that have a saddle or seat for use of a rider; is designed to travel on 2,3, or 4 wheels in contact with the ground and is not subject to registration under Title 13 of the Transportation Article of the Annotated Code of Maryland, Section 13-101 et seq. The purpose of this article is to require registration and regulation of vehicles defined above, on private property. (See Article 21, Title 12, Section 12-12-101 through 12-12-308 of the Baltimore County Code for the criteria on operating minibikes and off-the-road motor vehicles in Baltimore County.)
