FINDINGS OF FACT AND CONCLUSIONS OF LAW
FINAL ORDER OF THE ADMINISTRATIVE LAW JUDGE

This matter came before the Administrative Law Judge on January 11, 2012 for a Hearing on a citation for violations under the Baltimore County Code (BCC) section 13-4-201 (d), failure to store garbage in containers with tight fitting lids on residential property.

On December 22, 2011, pursuant to § 3-6-205, Baltimore County Code, Inspector David Gaine issued a Code Enforcement & Inspections Citation. The citation was sent to the Respondent by 1st class mail to the last known address listed in the Maryland State Tax Assessment files.

The citation proposed a civil penalty of \$500.00 (five hundred dollars).

The following persons appeared for the Hearing and testified: Timothy Campbell, Respondent and, David Gaine, Baltimore County Code Enforcement Officer.

Testimony was presented that, upon citizen complaint, an inspection of the subject property was carried out on 12/22/12, revealing the presence of full trash cans without proper lids as well as trash in bags placed on top of the cans. A pre-hearing inspection on 1/11/12 noted that the property was in compliance. The Respondent testified that he was not aware that keeping trash bags on top of garbage cans was contrary to law and would be in compliance in the future.

Having heard the testimony and evidence presented at the Hearing:

IT IS ORDERED by the Administrative Law Judge that a civil penalty be imposed in the amount of \$500.00 (five hundred dollars).

IT IS FURTHER ORDERED that \$400.00 of the \$500.00 civil penalty be suspended, with an immediate \$100.00 fine imposed at this time.

IT IS FURTHER ORDERED that the remaining \$400.00 civil penalty will be imposed if the property is not brought into immediate compliance.

IT IS FURTHER ORDERED that if the subject property is brought into compliance pursuant to this Order, the remaining \$400.00 civil penalty will be imposed if there is a subsequent finding against the Respondent for the same violation.

IT IS FURTHER ORDERED that if not paid within thirty days of billing, the civil penalty AND any expenses incurred by Baltimore County, as authorized above, shall be imposed and placed as a lien upon the property.

IT IS FURTHER ORDERED that the County inspect the property to determine whether the violations have been corrected.
