On 6/28/16 at approximately 1002 hours, Officer Trussell #5572 responded to 4 Sulky Court APT T4, 21133 in reference to a domestic.

Upon arrival, Officer Trussell spoke with Victim Korryn Gaines, who advised that she and her boyfriend, Suspect Kareem Kiane Courtney (B/M) got into a verbal altercation that turned physical. During the altercation Victim Gaines suffered minor scratches to her forearm area and red marks to her ear and shoulder area as well as defensive red marks to her hands. Victim Gaines advised that Suspect Courtney grabbed a chair and attempted to strike her with it. She also advised that he slapped her in the face and scratched her arms. Suspect Courtney then fled the area. Officer Trussell did observe the above described injuries sustained to Victim Gaines' person.

Units canvassed the area with negative results.

Victim Gaines advised that she would fill out a witness statement form at a later date. Victim Gaines advised that she did not need any medical attention.

Suspect Courtney and Victim Gaines have been together for approximately three years and have been living together for approximately three months. They have one child in common, Karsyn Courtney (B/F) and another child from a previous relationship, Kodi Saraa Courtney (B/M). It should be noted that both children were present to witness the altercation.
