AMENDMENT NO. 1

1. A **question** was asked: How should any snow removal using a shovel be billed?

Answer: It is anticipated that vendors would only need to use a shovel on steps or small areas. Please include any work manually shoveling snow under line 5, "Manual-push whirly bird salt spreader with operator."

2. A **question** was asked: Can I bid on snow removal for all of the sites, then withdraw my bid after bid opening if I decide not to perform at that location?

Answer: No. If you bid on a particular area, we would expect you to perform the work on that site.

3. The Hereford Library branch was omitted in error. It should have been included in the Texas Shop (West Side). A revised list of Texas Shop sites will be posted on the web site.

4. A pre-bid meeting was held at 9:00 a.m. on Tuesday, 6/21/2016. A sign in sheet of those in attendance is attached to this amendment.

5. The aerial map of White Marsh site was omitted in error and is attached to this amendment.

6. For clarification, this solicitation is primarily for snow removal at County Libraries and includes some adjacent or related properties. The site named Baltimore Highlands-Lansdowne (Inwood Shop), West Side is not a library branch, it is a Community Center, Senior Center and Park.

7. The following provision is added to the General Conditions:

16. CONTRACTOR QUALIFICATION.

16.1 Contractor must have active contracts supplying on-call/emergency services in the Baltimore Metropolitan area. Contractor must maintain an office in the Baltimore Metropolitan Area. The Baltimore Metropolitan area is defined as, but not limited to: Baltimore City and County, Washington D.C., Southern Pennsylvania, Prince Georges County, Montgomery County, Carroll County, Harford County, Howard County and Anne Arundel County.

8. All other terms and conditions remain the same.
