The following information is offered, as the result of correspondence received on December 16, 2016.

1. As a result of the questions received on December 16, 2016, the bid opening date has been changed to **Friday, December 30, 2016 at 3:00 p.m.** Attached, please find the updated Bid Reply Label.

2. **Question:** Is the purpose of this bid to find one supplier for all product lines to supply all makes applications or will the County consider supplier by commodity therefore having potentially several suppliers?

Answer: This solicitation may provide for multiple awards. Please see Section 6 of the General Conditions for bid, which states the following:
 - 6.1 Award of this contract may be in whole or in part. The County reserves the right to make awards on an individual item basis, combination item basis, or lump sum basis, whichever is in the best interest of the County. In accordance with Sec. 10-2-406 of the Baltimore County Code, 2003, as amended, past performance of bidders in furnishing goods and services to Baltimore County will be considered in determining the award.
 - 6.2 While Baltimore County intends to utilize all vendors receiving an award from this solicitation, the County does not guarantee a minimum amount of sales to any vendor receiving an award.

3. **Question:** How flexible is the 1 hour delivery requirement? We currently deliver to the areas where your shops are at 8:00 am, 10:00 am, 12:00 pm, and 2:00 pm.

Answer: Baltimore County is firm on the one (1) hour delivery schedule. In many cases, the parts and supplies utilized through this contract are for emergency vehicles, which must be returned to frontline service as quickly as possible.

4. **Question:** The request for price sheets (distributor, jobber and list) and the discounts from those prices are not apples and apples. How will this be equaled out when awarding the bid?

Answer: All discounts offered will be considered during bid evaluation. As stated in Section 6 of the bid, the County reserves the right to make awards on an individual, combination, or lump sum basis, whichever is in the best interest of the County.

5. Question: The last amendment showed the commodities in 2008 from 1-12. Are these the same commodities by manufacturer on the 2016 bid?

Answer: Attached, please find a detailed listing of the items awarded under the previous bid in 2008. As stated in Amendment 1, additional line items have been added to the current Request for Bid.
